WARNING: The present booklet, filled in with the requested data and in accord with the instructions provided, must compulsorily be returned back to the Association. The angler must fill it in using a pen with indelible ink and keep it with the other documents for fishing. If required by the fishing guards assigned to surveillance by the Association, the angler is compelled to provide it for the necessary controls.

Anglers must pay close attention to:

1. Signs advising “**Danger! Possibility of sudden flood waves due to maneuvers on hydraulic plants**”, especially in Limarò, on the river Sarca.
2. The use of **rods made of carbon or similar alloys** near power lines or during storms.

HOW TO FILL IN THE “CONTROL REGISTER OF CAPTURES”

Anglers must indicate (with indelible ink):

- 1) Before starting to fish: the **fishing ground**
- 2) After each capture and before starting to fish again:
 - a) Fishing ground
 - b) Time of fishing (M = morning --- P = afternoon)
 - c) The species of the Salmonids fished, marked with the following letters:
F = brown trout (*Fario*); **L** = Lake brown trout (*Lacustre*); **S** = brook trout (*Salmerino*); **TE** =

Greyling (*Temolo*); **I** = rainbow trout (*Iridea*); **M** = Marble trout (*Marmorata*); **C** = lavaret (*Coregone*);

3) Any change of fishing ground must be noted on the control register as described at points 1) and 2).

The date was March 11th In the morning (M), in the zone “A” (A), the angler captured and registered one brown trout (F); in the zone “U” (U) the angler captured and registered one rainbow trout; in the fishing ground “E” the angler captured and registered 10 perches (*Persico*). In the afternoon (P), in the zone “E” he captured and registered a lake brown trout (L); in the zone “G” he captured and registered one marble trout and, in the zone “C”, he captured and registered one pike (*Luccio*).

The blank space under **Fishing Ground** reports the zones where the angler has captured fish. Anglers who fish from a boat must add here the symbol “*” near the fishing ground letter. The angler of the example has fished in the zone “E” from a boat.

The blank **Control stamp** is reserved to fishing guards. Those who go fishing in the grounds GNK, *UNK1 and UNK2* (No Kill grounds) must obligatorily tick off all the blanks as in the following example:

The present internal regulation of the fishing season has been approved according to the article 18 of the provincial regulation on fishing.

PRACTICE OF FISHING AND ANGLER BEHAVIOUR

The practice of fishing in the waters ruled by the Association is related to the possession of a valid fishing license (the angler himself is responsible of the license validity) and of a fishing permit with the relative control register of captures. The mentioned documents are strictly personal.

If the staff assigned to surveillance by the Association requests them for the necessary controls, the angler is compelled to provide the aforementioned documents.

Regarding the rules about the notification of violations on fishing, refer to Art. 21, law 60/78: “Sono incaricati dell’osservanza della legge gli organi di polizia forestale, di vigilanza sulla pesca, gli agenti designati dalle Associazioni o società titolari di concessioni di pesca”: the compliance of the law is assigned to forest rangers, to fishing surveillance guards, to the agents designated by the Associations and the companies that hold fishing concessions.

Fish not released must be conserved on site, stored in appropriated and personal containers, and cannot be accumulated to other anglers' catch. It is forbidden to buy, sell and trade fish, as well as to throw away any kind garbage on the shores.

During the year, the angler must comply with prospective fishing bans, brought about on the occasion of contests organized by the Association; the Association disclaims all responsibility for accidents to things and persons occurred in the practice of fishing. **Please respect other people's property.**

WATERS IN CONCESSION AND FISHING GROUNDS

The waters assigned in concession to the association are the following:

Watercourses: river Sarca, from the footbridge in Limarò to the outlet into Lake Garda, Rimone I°, Rimone II°, stream Varone, Varoncello, Albola; Salagone, Salone, Saloncello, Bordellino, Galanzana, Magnone, Rio Secco, Acqua Fredda, Roggia di Vezzano, Roggia di Calavino, Roggia di Ranzo.

Still waters: Lake S. Massenza, Lake Toblino, Lake Cavedine, Lake Lagolo and Lake Tenno.

The aforementioned waters are subdivided into the following fishing grounds:

Note: *Fishing on watercourses/running waters is allowed on up to 4 (four) days a week (from monday to sunday) of the fisher's choosing.* Fishing is also allowed on any holiday although not included in the opening days reported in the previous table. This rule is not valid for the following grounds: M – Q – R – S – T.

All the waters in concession are closed for fishing from October 1st to the opening date specified in the table, except for the fishing ground F – C - D - E – that are open until October 31 and zones V, Z, Y, W, that remain open for all of october exclusively with No Kill techniques. In these zones, fishing is only allowed with the following bait: "dry fly", "rat tail" or bobber, with one single barbless hook. Any fish captured must be immediately released.

BANNED AREAS, BIOTOPES AND OTHER ZONES SUBJECT TO SPECIFIC NORMS

Anglers must respect fishing bans that affect the waters near dikes or dams. Areas subject to specific norms are identified with appropriate signage. The following waters are subject to a particular regulation:

Waters	Limits
Fishing ground P	From the catwalk at Limarò to the water meter in Sarche. A total of 15 fishing trips per

River Sarca at Limarò	year is allowed for owners of a yearly permit. The standard daily permit is not valid for this fishing ground. Those fishing at Sarca – Limarò cannot take with them fish from previously visited fishing grounds, nor non-authorized bait. A maximum of 4 (four) salmonid type fishes may be caught per day, total (not per type). Fishing of marmor trout is forbidden until further notice. Sanctions are doubled
Fishing ground D Lake Toblino Biotope	Areas where fishing is forbidden are indicated in the enclosed cartography: the red zone is always interdicted – in the yellow zone the interdiction is limited between March 15 th and June 30 th every year. In the yellow zone it is forbidden to get into the water.
GNK	A NO KILL zone is established on the canal Rimone 1°, from the bridge Olivetti to the bridge Ponte del Sachet. The opening date of this zone is fixed on May 1st every year. In this zone only dry-fly fishing is allowed, with one single barbless hook. Any fish captured must be immediately released. Those who fish in the GNK zone must adopt the NO KILL technique in any other zone they fish in, for the entire day. For violations in the NO KILL fishing ground sanctions are doubled.
K	From the ENEL power plant in Torbole to the outlet into Lake Garda, the minimum size of captured trouts (any species: brown trout, rainbow trout, marble trout, hybrids, lake brown trout) is 35 cm. Those fishing on the “K” grounds cannot take with them fish from previously visited fishing grounds. Sanctions are doubled
UNK1	<i>From the old bridge of Dro to the roman bridge of Ceniga; on these grounds fishing is allowed with artificial bait (fly fishing is forbidden) and with No Kill techniques, with one single barbless hook. Any fish captured must be immediately released. Those who fish in the UNK1 zone must adopt the NO KILL technique in any other zone they fish in, for the entire day.</i>
UNK2	<i>From the rapids by the Aquafil factory to the Mandelli fish farm water intake ; on these grounds fishing is allowed with artificial bait (fly fishing is forbidden) and with No Kill techniques, with one single barbless hook. Any fish captured must be immediately released. Those who fish in the UNK1 zone must adopt the NO KILL technique in any other zone they fish in, for the entire day.</i>
Fulfilling the agreement between the Association and Hydro Dolomiti ENEL Srl on the use of the canal ENEL in Dro for the experimental growth of the lake brown trout, being the mentioned area property of Hydro Dolomiti ENEL Srl, the two contracting parties establish by consensus that the access and the practice of fishing in the area are strictly forbidden.	

EQUIPMENT AND BAIT

In addition to what stated by the law and by the provincial regulations, the following rules are in force:

A - A1 - B - G - G1 - U - U1 - U2 - U3	The use of any bait is allowed, except for flesh fly maggots. For Cyprinids in the zone “U3”, in the section included between Torbole power plants and the outlet of the river into Lake Garda, it is allowed the use of vegetal chum, maximum quantity 2.0 kg, from March 1 st to September 30 th . It is allowed the use of a single fishing rod, equipped with a single hook for natural baits; the fishing rod must be constantly monitored. Angling with artificial fly (“camoliera” or “moschiera”, i.e. artificial baits that imitate the honeycomb moth and river midges) is allowed with a single fishing rod, equipped with maximum 2 (two) hooks.
H - H1 - I - L - M N - Q - R - S - T	The use of any bait is allowed, except for flesh fly maggots and artificial baits. The angler is allowed to use only one fishing rod equipped with a single hook for natural baits; the rod must be monitored. In the fishing ground “N” the hooks employed must have a maximum gap of 1 cm.

STILL WATERS

Zone	Means or method
C - D - E	The use of any bait is allowed, except for flesh fly maggots. The use of only one fishing rod is allowed, with a single hook for natural baits. 5 (five) is the maximum number of hooks allowed using artificial baits (“camoliera” or moschiera”); the fishing rod must be monitored. The use of two fishing rods at the same time is allowed from March 1 st to September 30 th ; the distance between the two rods must not be longer than about 3 meters. The rods can be equipped with maximum 6 (six) hooks and maximum 3 (three) artificial baits for each line; the two rods must be monitored.
F	The use of any bait is allowed. The maximum quantity of flesh fly maggots allowed is 50 gr. The maximum quantity of vegetal chum allowed is 0.5 kg. The angler is allowed to use only one rod equipped with a single hook for natural baits; the rod must be monitored. The capture of any species except for Salmonids is permitted also in the month of October.
O	The use of any bait is allowed. The maximum quantity of flesh fly maggots allowed is 20 gr. For the angling of Cyprinids it is allowed the use of vegetal chum: maximum quantity 0.5 kg. FOR THE ANGLING OF LAVARET WITH ARTIFICIAL BAITS (“MOSCHERA” AND “CAMOLERA”) the use of two fishing rods at the same time is allowed; the distance between the two rods must not be longer than about 3 meters. The rods can be equipped with maximum 6 (six) hooks (maximum 3 (three) artificial baits for each one) and must be monitored. Fishing from the island is allowed. Boat fishing is forbidden. On Saturdays fishing will start according to the following calendar: March > from 7.00 a.m.; April > from 6.30 a.m.; May > from 5.30 a.m.; September > from 6.30 a.m.
It is forbidden to carry baits that are not allowed on the place of fishing. Angling with dead fish as bait is allowed; live-baiting is allowed only with autochthone species: Bleak/Alborella (<i>Alburnus alborella</i>), Triotto (<i>Rutilus aula</i>), Common rudd/Scardola (<i>Scardinius Erythrophthalmus</i>), Common minnow/Sanguinerola (<i>Phoxinus phoxinus</i>), Vairone (<i>Telestes muticellus</i>) (see Provincial Law). In watercourses, the period from the second Sunday of February (February 10 th) to April 30 th , fishing is allowed only from the shore, in absolute respect to the spawning areas. <i>On lakes, anglers on the shore are not allowed to hinder other anglers already on location, regardless if on the shore or on a boat.</i> In all waters picking macroinvertebrates is forbidden from January 1 st to April 30 th . The use of treble hooks is always forbidden for natural baits, dead or live. The use of boats is allowed on the lakes S. Massenza and Cavedine from March 1 st to September 30 th (see Regulation on the use of boats)	

CAPTURE LIMITATION, MINIMUM SIZE, PERIODS OF PRACTICE AND FISHING BANS

For Salmonids the maximum number of captures per day allowed is 5 (five). Capture limits per day: maximum 4 lavarets – max 2 marble trouts – max 1 lake brown trout – max 2 greylings – max 3 Arctic char (*Salvelinus alpinus*) – max 3 pikes – max 20 perches.

Warning: once the 4th lavaret has been captured the permit validity stops (for that day) and it is forbidden to go on fishing (any species). Once the 5th Salmonid has been captured, the permit validity stops (for that day) and it is forbidden to go on angling (any species).

It is forbidden to register a fish on the given table before the capture. The size of a fish is considered from the end point of the head to the extremity of the caudal fin. Fish under the minimum measure illustrated below, when captured, must be released with great care and always handled with wet hands. In case it is not possible to free the hook without damaging the fish, the angler must cut the line, if possible without pulling the fish out of water.

Anglers are compelled to respect the minimum size limits illustrated in the following table:

DISCIPLINARY ACTIONS

In case of verified violation of the present regulation, the following disciplinary actions are applied: the permit will be immediately withdrawn by fishing guards and delivered to the Disciplinary Commission or dropped off at the Association seat. At the expiry of the sanction, the member will take care of collecting it. The offender cannot request a financial conciliation, as an alternative to the aforementioned measures. In case of controversies, the competent authority is the court of Riva and Trento.

- a) Fishing without a valid license, or with an expired license or if not authorized to the practice of fishing: confiscation of the permit for a period from 6 months to 1 year;
- b) Fishing with nets, with explosives, with electric power or with substances capable of numbing or killing the ichthyic fauna: confiscation of the permit from 1 to 3 years;
- c) For every specimen of Salmonidae captured beyond the daily limit: confiscation of the permit from 1 to 3 months.
- d) For every fish specimen under the minimum size captured: confiscation of the permit from 3 to 6 months;
- e) Fishing during a period of ban: confiscation of the permit from 6 months to 1 year;
- f) Angling in an area where fishing is prohibited: confiscation of the permit from 6 months to 1 year;
- g) Unlawfully introducing ichthyic species into the waters in concession: confiscation of the permit from 6 months to 1 year;
- h) Not registering fishing ground, day, single units captured: confiscation of the permit from 1 to 2 months for each single infraction;
- i) Late delivery of the control register of captures or incomplete compilation of it: delayed emission of the following permit from 1 to 2 months;
- j) Lacking delivery of the control register: delayed emission of the following permit from 2 to 4 months;
- k) Chumming in areas where it is prohibited: confiscation of the permit from 3 to 6 months;
- l) Use of more fishing rods than those admitted: confiscation of the permit from 3 to 6 months;
- m) Use of a fisheries echo sounder: confiscation of the permit from 6 months to 1 year;
- n) Whoever goes fishing on the canal ENEL in Dro will be prosecuted according to the provisions of the art. 637 c.p.

Warning: In case of violations not mentioned in the list above the Commission will decide on the adequate disciplinary actions. Periods of ban and suspension of fishing are not calculated in the computation of the sanctions. The actual time of the permit confiscation will be calculated in the light of the real period of fishing. It is reminded that disciplinary actions are doubled for violations occurred on the river Sarca - località Limarò and in the "No kill" zones (*GNK, UNK1, UNK2*).

The Disciplinary Commission is available on the second Friday of every month from 7.30 p.m. to 8.30 p.m. at the Association seat (Lago Bagatol di Dro - TN) to carry out disciplinary measures. All cases mentioned, if acknowledged as recidivism, are subject to doubled sanctions up to the definitive withdrawal of the Association permit. Every member is kindly requested to report any violation spotted on the waters in concession to the staff assigned to

surveillance by the Association or to the members of the Association Board (Direttivo). Anglers are requested to respect the environment and avoid throwing away paper, plastic and any kind garbage on the shores. The Association reserves the right to claim compensation for damages caused by offenders.

FURTHER SUPPLEMENTARY RULES

Regulation on the use of boats on the lakes Cavedine and S. Massenza

- 1) The Amateur Sport Fishing Association Basso Sarca allows the use of boats for fishing: sailing boats or rowboats. On lake Cavedine it is allowed to have a motor on board, that must be used according to the parameters prescribed by the Provincial Law in the field. The use of the motor during the practice of fishing is strictly forbidden.
- 2) The boat owner must be insured against any kind of risk related to the use of it on the waters in concession to the Association. Life jacket use on board is mandatory.
- 3) The use of a boat is allowed only to the members who reside in one of the eleven municipalities that compose the Association. Boat anglers must have the Association annual fishing license.
- 4) For members having annual or daily license who do not reside in one of the municipalities that compose the Association boat fishing is allowed only if a member that resides in one of municipalities of the Association and that owns an annual license accompanies them.
- 5) To go boat fishing, those who are not members of the Association must:
 - a) Have a daily permit;
 - b) Be accompanied by a member that resides in one of the eleven municipalities and owns an annual permit;
- 6) Boat fishermen must not hamper the practice of fishing to surf fishermen and keep a minimum distance of 100 meters from the shore. The penalty for offenders of this rule is the immediate withdrawal of the Association permit. The period of suspension is established by the Association Disciplinary Commission.
- 7) Boat fishing is allowed from March 1st to September 30th.
- 8) On lake Cavedine boat fishing is forbidden at less than 100 m from the outlet of the canal Rimone I° and lower than 50 m from the buoy that signal the ENEL power plants intake.
- 9) On lake S. Massenza boat fishing is forbidden at less than 100 meters from the ENEL drain.
- 10) At the end of the fishing session, the boat must be docked on land with a chain and a lock.
- 11) Before starting to fish, the boat must be at anchor. Trolling is forbidden in all the waters.
- 12) Boat fishing is forbidden in Località Laghisol on lake Cavedine.
- 13) It is strictly forbidden to carry on board and to use an echo sounder.
- 14) Before starting to fish, boat fishermen are required to indicate on the control register, in addition to the fishing ground letter, also the symbol * (example: E*).

Warning: what is not described in the present Internal Regulation is regulated by the provincial norms on fishing of the Provincia Autonoma di Trento (Province of Trento).

PERMITS – CONTROL REGISTER OF CAPTURES

To purchase a daily permit, it is necessary to show a valid fishing license and to pay the due price. Permits cannot be issued to the owners of an annual permit. Theft, loss, and permit destruction must be promptly reported to the Association that has issued them. At the end of the fishing day, the permit must be returned to the dealer or to the Association.
