

INSTRUCTIONS FOR COMPILING THE "CATCH CONTROL BOOKLET"

- Before starting to fish, the angler must, with indelible ink:
 - Write the current fishing ground (Zona di pesca) in the appropriate box
 - If fishing from a boat, write the asterisk symbol * next to the fishing ground letter (in the example below, E* indicates fishing with a boat in lake Cavedine on May 2nd)
 - If you are fishing CATCH & RELEASE, tick the appropriate NO KILL box and cross out all capture boxes for the whole day (see the example below for Wednesday - May 1st)
- If fishing for retaining, after each catch and before resuming fishing, indicate the fishing ground, the time of fishing (M = morning, P = afternoon), and the species of Salmonids you have fished (C = lavaret (Coregone), F = brown trout (Fario), I = rainbow trout (Iridea), L = lake trout (Lacustre), M = marble trout (Marmorata), S = brook trout (Salmerino), TE = grayling (Temolo). Furthermore: Alborella = bleak, Persico = perch, Luccio = pike
- At each change of fishing grounds, write the new one in the appropriate box.

Ex. May 1st: CATCH & RELEASE fishing in V, Z, NK1 grounds
Ex. May 2nd: Fishing from a boat in lake Cavedine. In the morning 2 Lavarets and one pike were caught. In the afternoon one lake trout and one brown trout were caught. The last catch of the day was a Grayling in zone G.

REGULATIONS FOR DAILY PERMITS

The personal information contained in this booklet is treated in compliance with the current legislation on the processing of personal data (data processing information published on www.apbs.it). By paying the fee or purchasing any other type of fishing permit issued by the association, the angler recognizes, accepts and agrees to comply with the provisions of these Regulations. The angler thereby also declares to be aware that they are fishing in the waters in concession or contracted to the Association at their own risk and exempt the Association from any responsibility for damages and claims. Furthermore, he or she declares to be aware that they may be required to compensate those concerned for any and all damages caused to anyone during the fishing activity.

ART. 1 – FISHING AND BEHAVIOUR OF ANGLERS

- Does not apply to daily permits
- Does not apply to daily permits
- Retained fish, with the exception of fish that is used alive, must be suppressed immediately and conserved on site and can not be combined with that of other anglers.
- It is forbidden to buy, sell and trade fish.
- During the year, the angler must comply with prospective fishing bans issued on the occasion of contests organized by the Association or otherwise authorized by the Autonomous Province of Trento
- All anglers must behave correctly towards other anglers and respect surveillance staff (wardens) and members of the Corporate Bodies of the Association.
- Please respect other people's property.
- At the request of the warden responsible for surveillance, the angler must produce the documents certifying the right to fish; those fishing from a boat must return to shore if so requested by surveillance personnel.
- The angler must, at the request of the surveillance personnel, retrieve the fishing line immediately, and showing what bait and means are being used.
- To allow the necessary checks, all anglers are obliged to open portable containers or other means of transport and vehicles with the exclusion of those constituting private residence.
- Anglers must not, both from a boat and on the shore, hamper the fishing activity of other anglers that were already on the spot.
- It is strictly forbidden to abandon waste of any kind (including lure boxes) in fishing areas both on the shore and in the water.
- All anglers are required to pay the utmost attention to the signs warning of "possibility of sudden floods", particularly on the Sarca river at Limarò;
- All anglers are required to pay the utmost attention when using carbon rods or similar alloys near power lines or during thunderstorms.
- All members are encouraged to immediately report any infractions of the regulations or cases of pollution or environmental damage that should come to their knowledge to the wardens.

ART. 2 – WATERS IN CONCESSION, CONTRACTED WATERS AND FISHING ZONES

a) The waters in concession to the Association are the following: Running waters (rivers and streams): The Sarca river from the Limarò catwalk to the outlet into lake Garda, and the following streams: Rimone "nuovo", Rimone "vecchio", Varone, Varoncello, Albola, Salagone, Salone, Saloncello, Bordellino, Galanzana, Magnone, Rio Secco, Acqua Fredda, Roggia di Vezzano, Roggia di Calavino, Roggia di Ranzo. b) The waters contracted from the Fishing Association Valle di Ledro are the following: Still waters (lakes): Lake Ledro

ART. 3 – OPENING AND CLOSING OF GROUNDS

a) Fishing in the streams in zones GNK, UNK1 and UNK2 (NO KILL) is allowed every day of the week. b) Fishing in zone P "LIMARÒ" is allowed only on Thursdays and Sundays. c) Fishing in zone K "SARCA FOCE" is allowed only on Mondays, Wednesdays, Saturdays and Sunday d) Fishing in other streams is allowed every day of the week except on Fridays. e) Fishing in the lakes Santa Massenza and Tenno is allowed every day of the week except on Fridays. f) Fishing in the remaining lakes is allowed every day of the week. g) If a lake, pond or artificial basin is mostly covered with ice, fishing in them and their inlets is prohibited for up to 100m distance from stagnant water (Fishing regulation of the Province of Trento) h) Fishing is also allowed on all public holidays, even if not falling within the opening days shown in the table above, excluding zones

M - P - Q - R - S - T. Fishing in zone P is also allowed on May 1st. i) Every water in concession is closed from October 1st to the opening date of the next season, with exception of the lakes (zones C - D - E - F - O) which will remain open until October 31st for fishing other than Salmonids fishing. j) Fishing in Lake Ledro (contracted waters) is allowed all year round

ART. 4 – TOOLS AND BAITS

a) In all the waters in concession to the Association fishing without levy (CATCH & RELEASE) is always allowed. Allowed means and baits are reported in art. 10 of this regulation. b) It is forbidden to bring to the fishing location bait which is not allowed in the specific fishing area. c) It is allowed to fish with dead fish of any species; for fishing with live fish only the use of native species is allowed (Common minnow, Common rudd, Common Bleak, roach, vairone, chub, cobite and common barbel). d) The collection of macro invertebrates is forbidden in all waters from 01/01 to 30/04. e) The collection of natural baits in the riverbeds is forbidden from January 1st to April 30th; this collection is always prohibited in waters closed to fishing. Removed pebbles must be returned to the water in their original place. f) Use of boats and similar (rowing boats, sailing boats, belly boats, canoes and similar) in the lakes of S. Massenza and Cavedine is allowed from 1 January to 31 October, and in Lake Ledro all year round. (see art. 9 – rules for use of fishing boats). Use of boats is prohibited in Lake Toblino as per the minutes of deliberation of the provincial council of Trento n. 160 of 21 January 2003. g) Except as provided by the law and by the provincial regulation, the use of the techniques and baits not referred to in the following table is forbidden.

C - D E	All baits are allowed except for flesh fly maggots. Simultaneous use of two rods with a maximum distance of 3 meters between them is allowed; these can be armed with a single hook for natural baits and with no more than 3 hooks on a single rod for artificial baits. If fishing with a single rod, only one hook may be used for natural bait and up to a maximum of five (5) hooks for artificial bait. The rods must be monitored. The use of fishing boats is allowed in the lakes Cavedine and Santa Massenza from January 1st to October 31st; it is forbidden in lake Toblino. Fishing for all species - excluding Salmonids - is also permitted in October. CATCH & RELEASE fishing is allowed (see art. 10)
F	All baits are allowed. The maximum amount of flesh fly maggots allowed is 50gr. The maximum amount of vegetable chum allowed is 0,5 Kg. The use of only one rod is allowed, regardless of the fishing technique used (natural or artificial baits); for natural baits only, the use of only one hook is allowed. The rod must be monitored. Fishing with a boat is forbidden. Fishing for all species - excluding Salmonids - is also permitted in October. CATCH & RELEASE fishing is allowed (see art. 10)
LE	According to the regulation of the amateur fishermen's association Pescatori Valle di Ledro: Night fishing is allowed from 1 July to 30 September for the following species: eel, carp, tench and burbot; The simultaneous use of 2 rods with a maximum of three hooks or three treble hooks each is allowed; The use of 5 hooks is allowed for the carmelier and for the musket with a single rod; The use of groundbait is limited to 500 grams of vegetable substance per day; Fish is permitted as live bait only if belonging to the following species: squalnerola, scardola, bleak, roach, vairone, chub, loach, common barbel including the larva of carnaria fly (bigatino); Fishing from piers is prohibited;

O	All baits are allowed. The maximum amount of flesh fly maggots allowed is 20gr. The maximum amount of vegetable chum allowed is 0,5 Kg. Simultaneous use of two rods with a maximum distance of 3 meters between them is allowed; these can be armed with a single hook for natural baits and with no more than 3 hooks on a single rod for artificial bait. If fishing with a single rod, only one hook may be used for natural bait and up to a maximum of five (5) hooks for artificial bait. The rods must be monitored. Fishing from the island is allowed. Fishing with a boat is forbidden. Fishing for all species - excluding Salmonids - is also permitted in October. CATCH & RELEASE fishing is allowed (see art. 10)

A - B - G - K - U V - W - Y - Z	All baits are allowed except flesh fly maggots. Use of a single rod, armed with a single hook for natural bait, is allowed. The rod must be monitored. For fishing with artificial bait a single rod may be used, armed with up to 2 hooks. CATCH & RELEASE fishing is allowed (see art. 10)
H - I - L - M - N - Q - R - S - T - X	All baits are allowed except flesh fly maggots. Use of a single rod, armed with a single hook, is allowed. The rod must be monitored. In the "N" zone, the hook must have a minimum opening of 1 cm. CATCH & RELEASE fishing is allowed; in this case the use of artificial bait is allowed according to the rules of art. 10.

For other zones refer to ART. 6 - PROHIBITED ZONES, BIOTOPES AND OTHER AREAS SUBJECT TO PARTICULAR RULES.

ART. 5 - CATCH LIMITS, MINIMUM MEASURES, AND PERIODS OF FISHING BAN

a) A maximum of 5 units per day is permitted for Salmonids. b) Does not apply to daily permits c) Does not apply to daily permits. d) Minors under 14 are allowed to retain up to 5 salmonids per day, which must be marked on the accompanying adult's capture control booklet and count toward the latter's daily total. e) ATTENTION: In all lakes the limit for lavarets is 4 fish per day; Once the 4th lavaret has been captured, fishing must be interrupted on the lakes; it is still possible to continue fishing on running waters until the end of the day. f) The measurement of the fish must be taken from the apex of the head to the end of the tail fin. g) Captured fish shorter than the prescribed minimum sizes listed below must be freed with the utmost care, and always handled with wet hands. Should it not be possible to detach the hook without damaging the fish, the line must be cut instead, if possible without removing the fish from the water. h) An angler may not capture and retain more than 5 kg. total fish per day, regardless of individual species. It is possible to exceed the total weight limit indicated above only if the limit is exceeded with the last captured fish. i) The following table shows the prohibition periods and the minimum measures for the individual species of fish.

ART. 6 - PROHIBITED ZONES, BIOTOPES AND OTHER AREAS SUBJECT TO PARTICULAR RULES.

- a) The anglers are required to respect the fishing prohibitions issued near dams and barriers.
b) Areas subject to special rules are signalled in such a way as to allow their identification by the angler.
c) The following zones in particular are subject to specific regulations:

ACQUA	LIMITI
Zone C Lake S.Massenza Zone D lake Toblino Zone E lake Cavedine Zone F lake Lagolo Zone O lake Tenno	In all lakes with the exception of lake Ledro, the limit for lavarets is 4 fish per day. Once the 4th lavaret has been captured, fishing must be interrupted on the lakes; it is still possible to continue fishing on running waters until the end of the day. Those coming from other fishing zones are not allowed to take with them any fish previously caught.
Zone P - Sarca river Loc. Limarò	From the Limarò walkway to the bridge on the state road in the locality Sarche (See border tables), a maximum of 15 fishing trips per year are allowed. Those who come from other fishing areas can not carry with them any fish previously caught or any bait that is not allowed in this zone. Fishing with only one rod is allowed using only SPINNING and FLY FISHING techniques. For fly fishing only, up to two baits may be used on the same fishing line. The use of artificial bait made of silicon or rubber, paste, and natural bait is expressly forbidden. In this zone the maximum capture limit is 4 (FOUR) SALMONIDES per day. (for ex. 2 Graylings + 2 Riverine brown trouts, or 4 Riverine brown trouts) In the Limarò area Marble trout fishing is forbidden until further provisions. Zone with limited fishing trips. Use the appropriate markers on the last page of the booklet.
Zona D Lake Toblino Biotope	The areas forbidden to fishing are indicated in the attached map: the red zone is always off limits; the yellow zone is off limits between 15 March and 30 June each year. Entry into the water is forbidden in this zone.
Zone GNK Rimone nuovo	NO KILL ZONE - From the bridge at locality "Ponte Olivetti" to the Sachet bridge downstream of the cement factory. In this zone entering the water is forbidden until May 31 to protect the reproduction of the Grayling. Only FLY FISHING is allowed in this zone, with up to two barb-less hooks. Every fish caught must be immediately released with the utmost care, possibly without removing it from the water.
UNK1 Sarca river	NO KILL ZONE - From the beginning of the cycling path Ceniga-Arco to the water intake at Malapreda. In this area fishing is permitted only with SPINNING techniques with a single barbless hook, or FLY FISHING techniques with up to two barb-less hooks. Every fish caught must be immediately released with the utmost care, possibly without taking it out of the water.
UNK2 Sarca river	NO KILL ZONE - From the Acquafil plant in Linfano to the water intake of the fish farm in Linfano. In this area fishing is permitted only with FLY FISHING technique with up to two barb-less hooks. Every fish caught must be immediately released with the utmost care, possibly without taking it out of the water.
Rimone nuovo	FISHING IS FORBIDDEN from the bridge north of lake Cavedine to the river mouth into the lake itself. Refer to the signposts on location.

K Sarca river mouth	From the HYDRO DOLOMITI power plant in Linfano to the river mouth into lake Garda. All baits area allowed except flesh fly maggots. Use of a single rod, armed with a single hook for natural bait, is allowed. The rod must be monitored. For fishing with artificial bait a single rod may be used, armed with, at the most, 2 (TWO) hooks. In this zone the minimum size of the trout is 30 cm except for the Lake trout whose size is fixed at 35 cm. In this area - the maximum capture of 3 (THREE) SALMONIDES per day is allowed. Those coming from other fishing areas can not have the fish previously caught with them. CATCH & RELEASE fishing is allowed (see art. 10)
Zone LE - Lake Ledro	FISHING IS FORBIDDEN OR LIMITED in the following areas: The archaeological zone (within 50 meter range) The mouth of the river Massangla in Pieve di Ledro (within 50 meter range) The area near the water intake by Mezzolago (area bounded by buoys) The area near the Sailing Club in Pieve di Ledro in June, July and August, from 8 am. To 8 pm.

- d) Those who go fishing in the NO KILL areas or who exercise in other waters CATCH & RELEASE fishing must necessarily tick the appropriate NO KILL box in the booklet, and cross out all catches for the day.
e) Following the agreement between the Basso Sarca Fishermen Association and HYDRO DOLOMITI concerning the use of the Fies power plant channel (Dro), for the experimental increase of the Lake trout, as this area is private property of HYDRO DOLOMITES, access to the canal and fishing therein are STRICTLY PROHIBITED.

ART. 7 - PERMITS - FISHING LOG AND CATCH REGISTER

- a) Annual and temporary membership permits are issued; these permits are personal and not transferable. b) This fishing log booklet and catch register is STRICTLY FOR PERSONAL USE and must be addressed to the individual physical person; IT CAN NOT BE SOLD, RENTED OR TRANSFERRED TO ANOTHER PERSON, EVEN FREE OF CHARGE. c) Not applicable to daily permits. d) Daily permits are obtained upon payment of the fee set for them. These permits are NOT to be released to holders of yearly permits. e) The log and catch register booklet is integral part of the permit; in the booklet, before starting the fishing activity, the angler must mark, with indelible ink and according to the instructions given in the booklet, the date and the fishing area and, each time, the captured fish. f) Not applicable to daily permits. g) Not applicable to daily permits. h) Before starting the fishing activity, the angler must, with indelible ink: I. Fill in the appropriate box with the „fishing zone“. II. Add the asterisk symbol * next to the fishing zone if fishing from a boat (example: E* to indicate fishing from a boat in lake Cavedine). III. If fishing in CATCH & RELEASE mode, tick the appropriate NO KILL box i) In capture mode, at each catch and before resuming fishing, indicate the fishing zone, the fishing period (M = Morning, P = Afternoon), the species of salmonid caught (C = Lavaret, F = River trout, I = Rainbow trout, L = Lake trout, M = Marble trout, S = Char, TE = Grayling). j) With each change of area, enter the „fishing zone“ in the appropriate box k) It is forbidden to register fish in advance (before its actual capture).

ART. 8 - DISCIPLINARY MEASURES

- a) If a violation of this regulation is established, they fishing guard may immediately withdraw the daily or multi-day fishing permit. b) In addition to the withdrawal of the permit, an infringement report will be sent to the Autonomous Province of Trento for the application of penal and fiscal sanctions provided for by the laws in force, and without prejudice to the provisions of Article 9 of the law November 24, 1981, n. 689 (Modifications to the penal system), for the application of administrative penalties provided for in Art. 22 of the Provincial Law of 12 December 1978, n. 60 „Rules for the practice of fishing in the province of Trento“.

ART. 9 - RULES FOR USE OF A FISHING BOAT

- a) The Basso Sarca Fishermen Association allows the use of fishing with a boat (rowing boats, sailing boats, "belly boats" and canoes or similar) only in the lakes of Cavedine and Santa Massenza. b) The contract with the Fishing Association Valle di Ledro also allows the use of boats and similar in Lake Ledro. c) Fishing with a boat is allowed from 1 January to 31 October each year. On Lake Ledro it is allowed until December 31st. d) On the lakes Cavedine and Ledro only, it is allowed to have an engine on board, to be used within the terms permitted by the Provincial Law on the subject e) On lake Cavedine use of the engine during the fishing activity is strictly forbidden (it is however allowed on lake Ledro) f) It is obligatory for every boat owner to be insured against any risk for the use of the same in the waters in our concession, as well as to bring on board and wear a life jacket. g) Fishing boats may only be used by associates in possession of a permit from the Association. h) In lake Cavedine, it is forbidden to fish within less than 50 meters from the buoys of the HYDRO DOLOMITI power plant water intake system. i) Fishing from a boat or similar is forbidden in the Laghisol area of lake of Cavedine; those fishing in the vicinity of Laghisol must keep at the distance marked by the line of signs on the shore. j) In lake Santa Massenza it is forbidden to fish from a boat within less than 100 meters from the HYDRO DOLOMITI water exhaust system. k) Fishing with trolling techniques is forbidden in all waters except Lake Ledro. l) On lake Ledro it is mandatory to maintain a distance of at least 10 meters between boats, and an anchor distance of at least 50 meters from the shore between June 1st and September 30th m) Fishing with "tirindana" is only allowed on lake Ledro, all year round between one hour before sunrise and one hour after sunset. In July and August fishing with "tirindana" is forbidden between 9.30 am and 7pm. n) Before starting the fishing activity, the vessel must be anchored (applies only to boats) o) It is strictly forbidden to use or even to have an echo sounder on board. p) Before starting to fish from the boat, the angler must indicate in addition to the fishing area the asterisk symbol * next to the zone letter (ex: zone E*). q) Anyone fishing from a boat or similar, upon request by surveillance personnel, must reach the shore and allow the control of both the documents attesting to the right of fishing and the vessel. r) For anything not covered in these Internal Regulations, the current legislation on fisheries of the Autonomous Province of Trento is applied.

ART. 10 - CATCH & RELEASE FISHING

- a) Catch & release fishing may only be carried out using the following techniques: SPINNING fishing with bait equipped with a single hook without a barb or fly fishing with no more than two hooks per line, without a barb. b) CATCH & RELEASE fishing can be carried out in all waters in concession, both normal and NO KILL (remember that in the GNK and UNK2 areas only fly fishing is permitted), provided that at the beginning of the fishing day, the appropriate NO KILL box in the activity control section as well as all relevant capture boxes are crossed out. c) Fishing CATCH & RELEASE excludes the possibility of fishing with different methods in all the waters granted to the Association on the same day. d) It is not allowed to keep the fish for the whole day. e) All captured fish must be immediately released into the water. If touching the fish is necessary for undoing the lure, this must be done with the utmost care and only with wet hands. IT IS ABSOLUTELY FORBIDDEN to manipulate the fish with dry hands or with the use of rags. The fish has to be released within the shortest possible amount of time.

ART. 11 - FISHING DURING THE MONTH OF OCTOBER
